Junior I Age 21-29

- All Privileges as Stockholder *except voting privileges*
- Monthly Dues: \$205
- Monthly Assessment: \$10
- \$600 Food Minimum
- Annual \$250 locker room/range usage fee per family
- ~~\$2,000~~ Initiation Fee
- **Spring Promo Initiation \$1,000 payable in three installments \$334 at time of application; \$334 - 120 days after acceptance, and \$332 due at one year**
- **Two Year Contract**

Business Social

- Monthly Dues: \$130
- Monthly Assessment: \$10
- \$1,500 Food Minimum-paid monthly/quarterly
- A Business membership can have up to 3 members listed under same membership.
- ~~\$1,500.00~~ Initiation Fee
- **Spring Promo Initiation \$750 payable in three installments \$250 at time of application; \$250 - 120 days after acceptance, and \$250 due at one year**
- Membership not extended to spouses, significant other, or family members
- Transfer of memberships available with no transfer fee
- Non profit organizations may join with a 10% non profit adjustment to dues.
- All other social privileges apply

Pool

- Unlimited Pool use from Memorial Day to Labor Day
