It is understood and agreed that Applicant may resign from the Club at any time by giving written notice to the Club and by paying any dues, house charges or unspent pro-rated food minimum for which Applicant may be liable and that upon such resignation, Applicant shall not thereafter be subject to any further dues or charges, nor shall Applicant be entitled to any privileges or benefits of the Club.

All services at the Club are to be signed for by the member and members will be billed each month for these services. Monthly dues and assessments are payable in advance and will appear on the regular monthly statement.
